Review Budget Committee by-laws

The committee reviewed and amended the Budget Committee July 2016 draft by-laws.

#1 Added "by the legislative body"

#10 Added "normally meet the second Tuesday of each month and"

#14 Changed to "The Budget Committee shall, by majority vote of the committee members present and voting, make recommendations regarding and included in each warrant article having a financial impact whether at the Annual Meeting or at a Special Town Meeting."

Discussion on budget goals including COLA and mil rate

Final COLA will be available in October. Recommendation for non-union employee raises will be reserved until the final COLA is received. Property value increase is available and known in April of each year. Discussed goal of minimizing tax increase with an eye on its effect on services. Paving: Members would like a copy of the updated paving study and the five-year plan. Stormwater: Actual work has exceeded the requirements.

<u>Discussion on Current Account Status and June Revenue and Expense Summary Report</u>

Items were not available. Discussion on why it was not available. Reason given were the numbers were not finalized. *Public comment: Jack Murphy stated he believed there were issues due to the revision to TREO.* The Chair will follow up on requests for the documents in "draft" form.
