5:36 PM 1. Town Manager's Report

Mr. Sullivan gave a financial update of Town investment progress, which is doing well. The final hearing for the York County budget is in two weeks, which is up 6% versus ours up 1.97%. Also, we took a look at the capital plan with Fire, Public Works, Administrative Assistant, Public Works Interim Consultant, and hoping to meet with Police next week. We would like to put this before the Budget Committee, the SB, and the voters for November. There are some part-time positions open at ECSD and Police Department. Regarding the Boat Basin, Police Chief Moya and Officer/Harbor Master Bill Dries were there on Memorial Day weekend to help and observe how the facility functions and strategize for improvements. Work continues with Comcast at Town Hall to improve video and sound for the installation of cable. We are experiencing a geese invasion and asking people to be careful when coming to Town Hall. The Town Clerk asked me to remind people to return their absentee ballots to Town Hall Tuesday, June 13th by 8PM.

5:39 PM

Mr. Wypyski, Budget Committee member, said I would like to underscore my support that our Town has over \$5.8 million in investments. The report indicated that they think we will make \$149,000 off those investments. As a Budget Committee, to me that's a really big deal. Thank you for your effort to upgrade our investment quality. I think this is a wonderful thing that relieves a lot of pressure. People should feel good in our Town that things are pretty good around here financially.

Mr. Donhauser moved, second by Ms. Dow, that the Eliot Select Board accept the Town Manager's Report, as presented, and ask it to be published on the Town website.

H. New Business:

5:46 PM 1. Maine DOT Route 236 Design Agreement

Mr. Sullivan said that this is a project to do a re-design from Depot Road to the Kittery line of Route 236. This is getting prepared for years out. This afternoon we had a discussion with the DOT representatives and they expressed to us that the Maine DOT is really committed to Route 236 and this is the first step. They are calling on the Town of Eliot to pay for half of the \$282,000 cost of the design. You will see from my next request from carry-overs from FY22, there was approximately \$262,000 left in the DPW budget. I am asking to carry those over and use them to invest in this project. Those are funds that don't affect your taxes, have already been appropriated by Town Meeting, and you are allowed to carry those over and invest them in the same part of the budget (consulting fees under DPW). That's the next order of business. If you feel you might not want to do that then you might want to consider whether you want to go forth with this cooperative agreement. I think it's the first step in solving a lot of problems. I have spoken with representatives from the Eliot Garden Club and they will certainly have a seat at the table as this design unfolds, as will the public with public meetings.

Mr. Donhauser asked if Kittery and South Berwick are contributing to this, involved in any way.

Mr. Sullivan said that they are being asked to invest in design. For Eliot, I would recommend the best course of action is to make the investment but still, going forward into the future, have the State be responsible for the bulk of maintenance, repairs, and things of that nature.

5:51 PM

Mr. Brubaker said that, in talking with the DOT and our folks at Southern Maine Planning, they both see Route 236 as a really important corridor and want to invest a lot of money in it. They have already started to invest in it and this is really an opportunity for the Town to be a partner on those investments.

Ms. Dow asked if this agreement document say anything about future financial obligation besides this design phase.

Mr. Sullivan said that it does not. I suspect that they are going to probably ask for some portion, between federal grants, money that the Maine DOT would put in, it sounds like the direction they are going in, in a number of their projects. I don't think it would be a 50/50 split but I think the public can expect some level of money. If they were to replace just the current lights at Beech/Dow Highway with the latest signals (arms over the road, etc.), those intersections are now predicted to cost \$1 million. I think it's a good investment but I think it's wise to make sure we're not making a commitment beyond just the design.

Ms. Dow was concerned with the possibility of setting precedence putting up 50%. Is there any room for us to say we could do 25% instead of 50% just to protect ourselves for the future.

Mr. Sullivan said that asking for the 50% for design is the standard across communities, I believe.

5:53 PM

Mr. Widi thanked Mr. Sullivan for finding the money. I think most people know what a hassle it is to come up with \$140,000+ at this exact time, where the budget for this upcoming year has already been submitted and voted on and put on the ballot. If we didn't have a series of circumstances that opened up that money, I don't even think we'd have that in the contingency fund. So, it's a small miracle that we actually have the money at this exact time. That's why we need a little bit of flexibility in the budgets, moving forward, because this stuff is not uncommon.

Mr. Sullivan agreed it was a good point to make that the grant opportunities are not going to wait 6 to 8 months for us to call another meeting. These grant opportunities are really strike-while-the-iron-is-hot, like this coming only two weeks ago. If we aren't able to take advantage, they will just move to another community that can.

Mr. Shapleigh asked if that is the final cost.

Mr. Sullivan said yes. Also included in the transfer is \$45,000 for the Kittery Comprehensive Transportation Study (KCTS), which will address the design at Goodwin Road and Old Dover Road.

5:54 PM

Mr. (Jim) Tessier, Johnson Lane, was concerned regarding the amount left from the DPW budget.

Mr. Sullivan said that items under health insurance, road repair, an unfilled position, a number of factors that added up to the total. It's about the same every year.

Mr. Tessier asked if they are still considering a round-about up by the Middle School.

Mr. Sullivan said that they have been very-well made aware that the Town is not enamored with a round-about. That's not to say it won't come up in discussions.

Mr. Donhauser moved, second by Ms. Dow, that the Eliot Select Board accept the Maine DOT Cooperative Agreement (026600.00) and authorize the Town Manager to execute the agreement on the Select Board's behalf.

5:56 PM DISCUSSION

Mr. Widi discussed the Kittery traffic circle. The whole point was to get a sidewalk to the community center. They got the Town to commit to \$200,000 in engineering and, in my opinion, they pulled a bait-and-switch to put other stuff in except a sidewalk to the community center, the one thing they wanted. So, moving forward, we need to be vigilant and watch them at every step.

Mr. Sullivan said that I appreciate that and that is what I think is one of the most important parts of public meetings, even if we have smaller meetings, to make sure we get input from the people who know the neighborhoods where these changes may take place.

Mr. McPherson said that that stretch of Route 236 is basically a race track, now, when they went to four lanes. To me, it makes no sense to go from two lanes to four lanes for a half mile, and back to two lanes, because it becomes a race track, which is part of the issue with emergency vehicles crossing there. In my opinion, northbound at Beech Road, the right-hand lane should be right turn only onto Beech Road. If you do that in both directions, I would think the race track part of it would stop.

6:04 PM

Mr. Tessier said that I believe the Police Chief made the same proposal that Mr. McPherson just made and the State shut it down; that they were more concerned with the volume of traffic moving through that intersection, not the safety issues you are talking about. He agreed that that intersection is not safe.

6:05 PM 2. FY22/FY23 Close Out Adjustments

Mr. Sullivan said that I'm asking to have \$190,000 of the FY22 balance carried over. That will satisfy the \$141,386 request for the Depot Road to the Kittery line design and, also, \$45,000 for the Goodwin/Dover Road design larger grant. It will also be applied to satisfy the small overrun in Snow and Winter for \$3,650. The second request is to have \$77,000 of contingency money applied to a FY22 shortfall from Administrative Expenses regarding an interim consultant hiring that was \$59,000 more than was budgeted; assessing interim consultant (\$6,800); two people separated from employment (\$5,600 & \$5,000).

Mr. Donhauser said that, as I recall, it took a while to get a new Town Manager and, as a result, we had to continue with an Interim Town Manager longer than we expected. That's one of the reasons for the use of contingency.

6:08 PM

Mr. Donhauser moved, second by Mr. Shapleigh, that the Eliot Select Board accept the FY22 closeout adjustments and carryovers, as presented.

DISCUSSION

Mr. Donhauser asked if we had to make a separate vote on contingency, as it takes a vote of the entire Board.

Mr. Widi said that this is a necessary step but I don't think it's a good thing to do year after year. He asked Mr. Sullivan if he had made adjustments to the upcoming budget to take account for those things a bit better.

Mr. Sullivan said that buy-outs and separation are not something we would normally put in the budget. It's not good fiscal policy to put it in there as, if it isn't used for that, it could end up being used for other purposes. There is enough money in the contingency reserve as we are asking for in the upcoming election.

3. ARPA Appropriation Request (Website upgrade)

Mr. Sullivan said that, at our last meeting, we had a meeting with Ryan Anderson and Megan Underwood of CivicPlus to discuss the upgrades and improvements we'd like to our website. We would bring in the ECSD website and the Police website to consolidate them all into one. Presently, they are operating separate websites. Our website is not up-to-date regarding technology. There are a number of advantages that we could put in place that would help the budget. The re-build is about \$40,000. That includes enough money for this year and we would like to have enough money to also pay for next year's licensure agreement. At that level, it will pay for a refresh every four years, which will prevent a big cost as it would

be built into the system. It is appropriate to use ARPA money, as one of the pillars of the ARPA money was to improve communications and that's exactly what we hope to do with this improvement.

Mr. Donhauser said that there is a finite amount of ARPA money.

Mr. Sullivan agreed. If you approve this, you have about \$480,000 left; that we have earmarked about \$180,000 of that for bicycle and sidewalk improvement projects. I would encourage you to allow this to go forward.
