Also, it was suggested that we add statutory citations where applicable, removing the wording "smooth transition", a change to Page 3, etc.
 - d. Grouping Budgets? There was consensus about 2 new "groupings" of article with sub accounts within the Admin Sub Hearings and Elections, and Add Roads and Bridges and Summer Roads as sub-lines within Public works.
