**5:49 PM** Mr. Widi asked if he could say something real quick. It's a question for Mr. Robinson, a constituent thing I said I would bring up and ask him and fill you all in on. There was some chatter on Facebook that people had salt that was higher in their wells than in years past and I said I would bring it up with Mr. Robinson and the rest of the SB. So, I did bring it up with Mr. Robinson and I just wanted to give him a chance to publicly respond.

Mr. Robinson said that we did talk. I dug into it a little bit and, because of the drought, the salt infiltration into the wells is higher during the drought, which we had all last summer and through the winter, and we are still in a drought. It's because the wells are low and that allows the salt to seep in. For the last two years, we've been well-below the normal use of salt. This last year, we only used 1,850 ton. The year before it was actually less than that and, on average, over the course of the last 10 years, we usually use between 3,000 and 3.500 tons of salt. It all has to do with climate, the drought, and we take precautions in different areas to not spread as much salt. With the climate, there's not much we can do about it and I know people love to have their roads when they get up and go to work in the morning.

**5:50 PM** Mr. Widi said that I will relay that for everybody, publicly, on Facebook. For SB members, it was kind of starting to snowball on Facebook with people blaming the salt in their wells on road salt. I wanted to give Mr. Robinson a chance to dig into that. Thank you, Mr. Robinson.

Mr. Orestis said that the total cost to get that truck outfitted is \$64,325.97. I just feel that's important information to get out there, all those numbers added up. Does that sound about right.

#### 5:52 PM 7) Town Manager Report

Ms. (Carol) Granfield, Interim Town Manager, said that I've been there, now, two weeks. Typically Mondays and Tuesdays and the staff has been great. I've had meetings with all the departments. We're going to start bi-monthly meetings with the department heads. Moving forth with the Town Manager Search Committee, they sent letters out and that will be meeting next week. We are currently recruiting the Assessor position. TextMyGov is something that will be coming out. We anticipate that, towards the end of May, it will be live and more information will be coming out. Basically, I think it will be great for the public because they can text; that not everyone uses computers and they can get a quick response. We are evaluating that now. Regarding the Route 236 water/sewer project. Underwood or their subcontractors will be out next week along Beech Road and State Road doing geo-tech investigations, including borings. After that, when they're done on Beech Road and State Road, they'll move to Route 236. Regarding COVID, we're continuing to monitor that. The majority of employees have all received at least the first vaccination shot. The Governor extended the State of Emergency to May 13<sup>th</sup> and we had been going along with that. April 30<sup>th</sup> was when we had extended the hours change at Town Hall, so, we think we'll keep in the same line and anticipate probably the next month we'll be able to move forth to having Town Hall open more hours. Probably Monday through Thursday, 7AM to 4:30PM, something of that nature. But we're not going to do that, as yet, sticking with the Governor's plans. Lastly, I was contacted by the Public Works Union regarding starting negotiations. They wanted to know if we wanted to wait, or in the interim, and we thought it was best because the contract ends June 30<sup>th</sup>. So, with that regard, a couple questions. I know that there have been SB members as liaisons and I would like to know who would be the liaison once they get started. Also, in the past we've used a couple of different labor negotiators and wanted to pursue which one we might utilize for that. We haven't been contacted, yet, from the Police but I anticipate it because I believe their contract ends the same June 30<sup>th</sup>. So, we may be hearing from them, as well. I also just wanted to commend the staff; that they've been great. They are a great group of employees and they've been doing above and beyond what they normally do. I think they've been a great help in the transition and I think they've done an excellent job. That's my report and happy to answer any questions you might have.

**5:55 PM** Mr. Orestis said that I think it's the Police Union that's ready to get going. I haven't seen anything from the Public Works Union come through, yet. I know

that previous correspondence, for Mr. Donhauser and myself, have been on with our attorney Bob Bower and the Police Union.

Ms. Granfield said that I did receive today and it was about the Public Works Union. So, we'll be moving along with that.

Mr. Donhauser asked Mr. Miles if there were any highlights or comments you would like to make about where we stand, currently, in this year's financial situation.

Mr. Miles said that I feel really good about this year. There was something that I brought up to Ms. Granfield a little earlier and thinking, in going forward, I know that this SRO thing has been kind of a little hiccup and, knowing that the PD is well-under budget this year because they've been done an officer, I was thinking that maybe the SB could think about rolling some of that money forward into a reserve to help fund that position in the future years so it's not such a big hit on the tax base. It's just an observation I made going through everything, lately.

Mr. Donhauser said that we should consider that. Perhaps we could put that on our next meeting agenda.
