9	1.	Roll Call – Vice Chair Fernald opened the meeting and announced a quorum.

11	2.	Discuss Referendum Town Meeting ordinance Revisions. The Town manager was asked to re-	
12		can the night's work. He stated that during last year a few things had become	
13		cap the night's work. He stated that during last year, a few things had been noted that could	
14		be changed in the Referendum Town Meeting ordinance or related documents that would	
15		help smooth the process. He stated that the Budget Committee and Select Board had both	
13		indicated a desire to roll summer roads and roads and bridges into the overall PW budget.	
16		Dana read a memo from the Town Clerk about her concerns (see attached).	
17		It was discussed that a couple of the changes recommended by the Town Clerk appear to need	
18		a charter change. The group discussed the difference between a substantive change to the	
19		charter requiring a whole new charter commission, versus an amendment which, by our	
20		charter, can be done by appointing a charter review committee. They asked Dana to check	
21		with an attorney as which type of charter change this would be defined as.	
22		Brad said the Budget Committee had endorsed the idea of combining summer roads and roads	
23		and bridges into the overall PW budget, as well as most of Winter Roads, except for winter	
24		salt, sand, wages and benefits.	
25		It was suggested that Dana search the Charter to see if "warrant" appears in it, and to see if	
26		the Town Clerk is asking the Select Board to add to the charter to allow more time than basic	
27		state law.	
28		Jack noted an error in Section 9, Para 3 – delete redundant "Board of"	
29		Jack noted that the wording in Section 10, Para 4 is insufficient to explain what gets paid and	
30		to whom. He suggested "paid to the taxpayer for abated, paid taxes for the fiscal year." Brad	
31		asked about abatements and how and when they occur. Dana explained.	
32		It was suggested that when we re-structure the PW budgets and roll in repairs and diesel into	
33		the general PW budget, we should note which portion of repairs, and which portion of diesel	
34		was moved (has been set aside) from winter roads in the event of a winter spending overage.	
35		Bob noted the overage limit was about 15% by law.	
36		It was agreed to scratch Ambulance and Public Health Officer from Public Safety. It was
