Dear TOWN OF ELIOT:

As you may be aware, Portland Natural Gas Transmission System ("PNGTS") and Maritimes & Northeast Pipeline, L.L.C. ("Maritimes") jointly own an interstate natural gas transmission facility that abuts your property. This facility is operated by M&N Operating Company, LLC ("MNOC"). As part of its proposed Portland XPress ("PXP") project, PNGTS is seeking approval for certain modifications and upgrades to this facility. MNOC is responsible for assisting PNGTS with PXP, including all necessary public notifications, regulatory filings, and construction of the facilities modifications, if approved.

Growing natural gas demand for heating, industrial processes, and electric generation has driven an increased need for infrastructure to access abundant North American natural gas supplies. PXP will help ease these constraints without the need for construction outside existing facilities. More specifically, PXP proposes to modify the existing Eliot Compressor Station in Eliot, Maine, by installing one (1) new 6,130 horsepower compressor unit and appurtenant facilities, as well as make modifications at the Westbrook Compressor Station in Westbrook, Maine, and the Dracut Meter Station in Dracut, Massachusetts, enabling PNGTS to deliver additional capacity to New England.

The purpose of this letter is to introduce PXP to you. We have also begun updating community leaders and elected officials about the project. Additionally, MNOC & PNGTS will be hosting informational open houses in your area. Project experts will be available at these meetings to answer your questions about PXP. The meetings are open to the public, and we encourage you to attend. The dates and times for the meetings are listed below
